1. Community and Public Service

2. Model of integrity for young people

Provide dates and examples, past and current.

3. Professional Success

Provide biographical and professional information, including evidence highlighting academic, career, or other significant achievements.

4. Provide a written bio for the nominee as if it were a press release. It should be no more than 300 words.

5. Provide additional information that you feel would help the selection committee. Examples may include specific activities, leadership roles in organizations or agencies, elected positions, a current resumé, or excerpts from press releases or supporting articles. The submitted nomination form and additional information is limited to a **maximum of 15 pages.**

### **Hall of Fame Dismissal**

The policy on revocation from the HOF - as well as revocation of the honors bestowed on the Inductee - states that the honor of induction into the LSHS Hall of Fame can be revoked if a recipient's conduct departs from the high standards of the award and undermines the credibility, integrity and/or purpose of the induction. Induction into the LSHS Hall of Fame is based on three pillars: professional accomplishment, public service, and character. Removal from the Hall of Fame would require a majority vote by the committee. The Inductee will be notified of

revocation by the committee.
